# Schalamar Creek Mobile Homeowner's Association HOA Member meeting May 13, 2019

The May 13, 2019 Member meeting began with representatives from Lakeland Electric Company giving a power point presentation. They showed a chart which gave electric usage yearly, monthly, daily and hourly. Users can use the company's website to see their own usage by going to <a href="www.lakelandelectric.com">www.lakelandelectric.com</a>. It will show reasons why someone's bill has gone up or down. Cooling takes the most electricity and the hot water heater takes the next most. Their suggestion was to put a timer on the water heater to shut it off during peak user times to save money. Everyone thanked them for sending immediate information during the recent power outage here.

President Stan Kubik called the business meeting to order. It began with reciting the Pledge of Allegiance and a moment of silence to remember neighbors who have passed.
