Secretary, Norma Miller- The minutes from our last Member meeting on May 24, 2021 were approved.

September financial reports include: Various HOA groups have been purchasing needed items recently. Bank Balance of \$15,735. HOA group expenditures: Bingo board, refrigerator, freezer, pickleball and shuffleboard equipment, piano tuning. Income for September- \$925 and for the year- \$20,285; Expenditures for September- \$3,574 and for the year-\$11,058. Most of our income comes from advertising received from the Newsletter and Directory for which Ted and Ginny Reid were thanked.

FMO Representative, Randy Gray- He has received new information regarding the Federation of Manufactured Home Owners of Florida, Inc. (FMO) which he feels is a positive step forward. They have released their Legislative agenda for the 2021/2022 session. State officers have met with the Dept. of Business and Professional Regulations (DBPR)-Division of Florida Condominiums, Timeshares, and Mobile Homes and with the Florida Manufactured Housing Association (FMHA) who convinced the FMO that more teeth are needed in the state regulations that we must follow, Florida Statutes Chapter 723. An area of particular concern was the low monetary amount of fines and penalties levied by the DBPR from manufactured home owners' complaints against park owners for violations of SS723. Our FMO Lobbyist will be drafting proposed legislation to be presented to the state legislative committees.
